ARTICLE FOUR

SEC. 1—Phone rentals for phones in use upon the farm lines shall be due and payable quarterly in advance; rentals for phones used in town shall be due and payable in advance each month, and a failure to pay the rental for a phone within 30 days after due shall be deemed sufficient cause for the removal of the phone or phones.

SEC. 2—All phone renters and their families, as hereinafter defined, shall have the use of the lines of said corporation EXCEPT TOLL LINES, free of charge except the regular monthly rental:

Members of one family shall be confined to man, wife and their children under 21 years of age living at home; and said phone may be used by the servants, boarders, employees and other occupants of the house or place of business, only in transacting business as an employee of such subscriber and in the interest of such subscriber; any personal use of said phone by a servant, employee, boarder, lodger or other occupant of the house or place of business, shall be considered as the use of a phone by a non-subscriber; and such servant, boarder, lodger, employee or other occupant of the house or place of business shall be charged and required to pay the regular toll rates charged and collected from other non-subscribers for like service.

SEC. 3—When a non subscriber wishes to use a phone on a rural or farm or toll line, the renter of said phone shall first ring up and report to the central office the party's name who wishes to talk, and to whom he wishes to talk.

SEC. 4—Each renter whose phone is used by a non-subscriber shall be responsible to the corporation for the fee charged to other non subscribers for like service and shall turn over said fee to the secretary of said corporation at the end of each month.

SEC. 5—Each renter receiving calls or messages from a non-subscriber shall report each and every one to his central office at once

SEC. 6—If any subscriber fails to pay within 30 days after it becomes due, his or her phone rental, or to pay the fees collected by subscribers from non-subscribers, the phone service to said delinquent subscriber shall be discontinued until said indebtedness is paid.

SEC. 13.—When any non-subscriber is delinquent in his or her payments, for telephone service furnished such non subscriber by this corporation and refuse or fail to pay said indebtedness, said non-subscriber shall be refused further service until said indebtedness has been liquidated.

The first figure stands for the number of the line. The next two figures represent the ring, as—number 702 means two short rings on line seven, etc.

Call by number only.

Ring off when through talking.

Your central will answer by saying "Humboldt," "Bode," etc., for each exchange.

Don't keep asking if "this is central."

Ring clear and distinct.

No ringing after 10:00 p. m. and before 6:00 a. m. will be allowed except emergency calls.

The general or emergency ring on all farm lines will be Seven Short Rings repeated several times. This ring to be used in case of fire or accident or for weather reports, etc. The general ring should be answered by all on the line as it may save the loss of life or property.

GENERAL INFORMATION

RENTALS BUSINESS PHONES—Wall sets \$1.50, Desk sets \$1.75 per month.

RESIDENCE PHONES—Wall sets \$1.00, Desk sets \$1.25 per month.

EXTENSION SETS, 50 cents per month.

EXTENSION BELLS, 25 cents per month.

FARM PHONES—\$1.25 per month with a rebate of 25 cents per month if paid quarterly in advance on or before the 15th day of the first month of the quarter.

To subscribers who expect to be absent from town for more than one month we will leave telephone in at one half the regular rate—or we will take out the phone and install again when you return at a charge of \$2.00. In both cases you must notify the company before leaving.

TOLL LINE SERVICE—All calls put in over our regular toll line circuits must be paid for at the regular toll rates—Our toll lines are NOT FREE to anyone. Call toll operator for this service.

We give our subscribers free service over our farm and grounded lines between our different exchanges, limited to 5 minutes use of lines at one time. Please observe this rule and do not hold lines over time as there are others waiting for the lines.
